This small animal trainer incorporates all the necessary features for teaching basic dog CPR to pet owners. The anatomy features a full body, molded in the appropriate position in which to give CPR, nostrils, retractable tongue, moveable jaw, sanitary replaceable airway, foam-filled body for chest compression resistance, and a femoral pulse.

Pinch nostrils and insert closed end of airway. Push airway in about half way.



Pull out foam block.

Reach into chest cavity and pull airway out of the airway tube.



Pull out used airway.

Unfold the airway and spread it out in the bottom of the chest cavity. Replace the foam block and the back plate.

Spread the airway bag over the snout. Inserting a finger into the nasal passage will ensure that the airway is open.

Fold new airway in half 4 times.

Install the pulse bulb assembly tubing into the port located on CasPeR's hindquarter. A simulated femoral pulse can be felt on the inside of the upper leg when the bulb is rhythmically squeezed.

CasPeR Lung 100 Pack No. 5001 CARE AND MAINTENANCE:

Using a solution of mild soap and warm water, clean with a damp cloth and allow to thoroughly dry before storing.

CAUTION: Do not allow foamed portion of manikin to become wet. If the foamed portion of the manikin becomes wet, allow it to dry thoroughly before storing.
